BHA Board confirms removal of restriction on overseas runners in Class 5 & 6 Flat Handicaps and Classified Flat Races

The BHA has confirmed that a restriction on overseas-trained runners in Class 5 & 6 Flat Handicaps and Classified Flat Races has been removed.

The restriction will be lifted from the end of the turf season in Britain, affecting races staged from Monday 11th November onwards.

IRISH HORSE RACING REGULATORY BOARD

The Directors of the IHRB, at their Board Meeting on September 4, 2024, approved the following changes to Rule 87(ii) which will become effective on October 1, 2024:

"87(ii) A Horse is not qualified to start for any Race:

(j) Unless returned in training in accordance with Rule 148(xii) for no less than seven days prior to running in a Race."

Island Hunt (F) Point to Point Meeting Sunday 20th October 2024 4yo Maiden

The Acting Stewards interviewed Mr B. Finn, rider of Sheer Raz, placed second, concerning his use of the whip in the latter stages of this race. Evidence was heard from the rider concerned.

Having viewed a recording of the race and considered the evidence, the Acting Stewards were of the opinion that the rider was in breach of Regulation 58. 3.(i) in that he had used the whip without allowing his mount at least three strides to respond. Having taken his previous record into consideration, the Acting Stewards suspended Mr B. Finn for one Point to Point race day.

Appeals & Referrals

Appeal

The Appeals Body, Mr Nick Wachman (Chairman), Mr Laurence McFerran and Mr Neil McGrath convened at Offices of the Irish Horseracing Regulatory Board on Tuesday, 15 October to consider the appeal of James Ryan (Rider) against the decision of the Raceday Stewards at The Curragh on Saturday, 5 October 2024.

On the day, following the running of the Gormley's Gallery Handicap, the Raceday Stewards found Mr Ryan, rider of Saturn Seven, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard they suspended him for four racedays.

The grounds of appeal lodged by Mr Ryan was that the Raceday Stewards on the day erred in their decision.

At the appeal hearing, evidence was heard from Mr Ryan. The Appeals Body also watched a recording of the race.

In his evidence, Mr Ryan explained that his horse quickened up well and his mount dived left in the closing stages. Mr Ryan stated that he did everything in his power to correct his mount. Mr Ryan further stated that there was a strong cross wind on the day which could have contributed to his mount not reacting quickly enough to his correction.

Having considered the evidence, the Appeals Body allowed the appeal.

The appeal was presented by Mr Ryan, accompanied by Mr Niall McCullagh, Jockey Coach to Mr Ryan. The IHRB was represented by Mr Andrew Ring, IHRB Stipendiary Steward.

Referral

The Referrals Committee, Mr Nick Wachman (Chairman), Mr Laurence McFerran and Mr Neil McGrath convened at Offices of the Irish Horseracing Regulatory Board on Tuesday, 15 October 2024 to consider a referral from a Senior Racing Official under Rule 27(vii) of the running and riding of Firm Belief, trained by Rodger Sweeney and ridden by Phillip Enright in the Buckley Agri New Holland Irish EBF Mares Maiden Hurdle at Listowel on Thursday, 26 September 2024.

This matter was referred following an investigation by a Senior Racing Official into possible breaches of Rule 212 by the Trainer and Rider.

At the Referral Hearing, the panel considered evidence from Mr Sweeney and Mr Enright. They also watched a recording of the race.

In his evidence, Mr Enright stated that his mount was not a natural jumper, and she switched lead after the third last hurdle and became unbalanced. Mr Enright stated that he moved out to his right in an attempt to get her

balanced and to switch back onto the correct lead at the point of the home bend, Mr Enright accepted that he was riding on the previous days ground at this point, but felt that it was of little consequence, and he was satisfied that he gave her the best possible ride.

In his evidence, Mr Sweeney confirmed the instructions he gave to Mr Enright. Mr Sweeney also explained that his charge is a difficult mare at times. Mr Sweeney confirmed he was happy with the ride that Mr Enright gave to his mare and stated that his main objective was to get form into the mare as he hoped to breed from her.

Having considered the evidence, the Referrals Committee noted the explanations offered and took no further action.

The case was presented by Mr Liam Walsh, IHRB Senior Stipendiary Steward. Mr Sweeney and Mr Enright were represented by Mr Patrick Kennedy of Patrick J. O'Meara Solicitors, Thurles, County Tipperary.

Referral

The Referrals Committee, Mr Laurance McFerran (Chairman), Dr Paddy Moloney and Ms Mary Cosgrave convened in the Stewards Room at The Curragh Racecourse on Thursday, 17 October to consider a referral from a Senior Racing Official under Rule 27(vii) to review the Student Raceday on October 28th INH Flat Race at Galway on 8 October 2024.

On review, it appeared that Lelia Byrne, rider of Matter of Opinion may have been in breach of Regulation 10, regarding her use of the whip during the running of the race. The matter was subsequently referred to the Referrals Committee under Rule 27(vii).

At the Referral Hearing, evidence was heard from Ms Byrne. The Referrals Committee also watched a recording of the race.

In her evidence, Ms Byrne accepted that was in breach of Regulation 10.3(g) and Regulation 10.3(i) and she apologised for her actions.

Having considered the evidence, the Referrals Committee found Ms Byrne in breach of Regulation 10.3(g) (excessive frequency) and Regulation 10.3(i) (time to respond) and having considered her clean record in this regard, they suspended her for five racedays.

The case was presented by Ms Shona Murphy, IHRB. Ms Byrne represented herself at the hearing.

The Racing Calendar Office of Weatherbys Thoroughbred Ltd. receives entries submitted for acceptance as agents for the Racecourse Authority and only upon the terms of the Standard Conditions. Acceptance of entries is subject to the power to refuse to allow entries to be accepted conferred by the Orders and Rules of Racing on the British Horseracing Authority Ltd. This declaration is not considered as an entry. Trainers are to make their entries and other declarations directly online. They must also supply a complete race record of all the performances of the horse(s) entered on the Internet, by fax (33 1 47 61 93 37) or email (fgperf@france-galop.com). The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.

The British Horseracing Authority will amend paragraphs 34 to 38 of the Weights and Handicapping Code and paragraphs 62 to 65 of the Race Entry Code in the event that raising of the weights at the 24 hour stage proves necessary.

Trainers are reminded of the provisions of paragraph 41 of the Race Entry Code which require that they MUST notify the Racing Calendar Office IMMEDIATELY when the decision has been made not to run.

This will maximise the list of runners and determine whether the weights will need to be raised.

The British Horseracing Authority will modify the Rules of Racing as a consequence of providing two reserves for this race. The non runner penalty will be waived for any horse which is deemed a non-runner by 1.00 p.m. on the day before the race.

All entries in this race will have their suitability assessed by the Grand National Review Panel and if necessary, The British Horseracing Authority may exercise its powers under Rule (I)2 to refuse to allow a horse duly entered to run when it has reason to be concerned about the horse's suitability for the race.

All runners must be presented to the BHA Veterinary Officers for a pre-race veterinary inspection and must pass the inspection. Any horse considered unfit to run will be withdrawn by order of the Stewards of the Meeting under Rule (H)7.4.

Horses may be presented on the morning of racing as advised. Subject to the discretion of the Stewards, any horse which is not presented for a veterinary inspection by the advised time will not be permitted to run under Rule (H)7.4. The British Horseracing Authority has modified paragraph 6 of the Weights and Handicapping Code for the purposes of this race, such that racecourse performances up to and including the Sunday after closing may be taken into account.

The British Horseracing Authority has modified the Declaration of Jockey section of the Race Entries Code and the Division of Races section of the Race Administration Code of the Rules of Racing for the purposes of this race.

Nominations can only be made and accepted on the condition that the nominator subjects himself/herself, in all respects to the Rules & HRI Directives under which each race is run.

Races and divisions are run subject to the provisions of Rule 20.

Handicap races closing under the Irish entry system will be calculated at the time of closing.

The rating qualification will take into account all performances up to and including the **Sunday** previous to the rating qualification date.

In accordance with Rule 101 (iv), the Qualifying Ratings shall be calculated on each Monday at 12 noon. The Qualifying Rating for each horse shall be equivalent to the horse's current Rating at that time.

Qualifying Ratings For Flat Races

For the purposes of qualification for flat handicaps, in the event of a horse being assigned a separate handicap mark for "all weather" handicaps, the "all weather" qualification rating will be the horse's qualifying rating for "all weather" racing. In the event of a horse being assigned only one handicap rating, the same qualifying rating shall apply for qualification purposes to handicaps run on both turf and "all weather" surfaces.

'Novice' for hurdle races is a horse which has not won a hurdle race prior to 5th May 2024 and for steeplechases is a horse which has not won a steeplechase prior to 5th May 2024, other than one hunter steeplechase within the previous two National Hunt seasons. However, any horse which wins a hurdle race for the first time or a steeplechase (hunter steeplechase excluded) for the first time between 1st February 2024 and 4th May 2024, will be qualified as a 'Novice' for the period up to and including 1st December 2024 other than the winner of a Grade 1 Weight For Age Hurdle or Steeplechase prior to 5th May 2024.

Overnight Nomination Of Rider & Colours

Under Rule 195, it is compulsory to nominate a rider for each declared horse by 12 noon on the day that Declarations close. Under Rule 155 the trainer must declare any intended change of colours or any colours in use that are not registered with Horse Racing Ireland for racecard purposes. In such instances the declaration of colours must be made to Horse Racing Ireland by 12 noon on the day the declarations close unless otherwise stated.
