IRISH HORSERACING REGULATORY BOARD

The Directors of the IHRB, at their Board Meeting on 11 December 2024 approved the following changes to Rule 148 (xii) which will become effective on 8th February 2025:

148 (xii) [TEXT DELETED]

- A Trainer must maintain, in (a) the manner prescribed, accurate, current records of the identity and location of each Horse at their Training Establishment or under their care and control at any other Location.
- (b) A Trainer must notify HRI within twenty-four (24) hours when any Horse:
- (i) arrives into or leaves the Training Establishment or the Trainer's Care and Control,
- (ii) is gelded, or
- (iii) dies.
- (c) When a Horse is leaving a Training Establishment or the Trainer's Care and Control, including upon its retirement from racing, the Trainer must notify HRI of the Horse's new location and provide the necessary details of the individual(s) or entity taking charge of the Horse.
- (d) For a Horse to be eligible to run in a Race, it must have been under the continuous care, control and training of the Trainer at the Trainer's

Training Establishment, for at least 14 clear days prior

to a Race (e) Failure to comply with these Rules may lead to sanction including but not limited to the cancellation of an entry, withdrawal of a Horse from a Race, a fine, and or disciplinary action.

IRISH HORSERACING REGULATORY BOARD

The Directors of the IHRB, at their Board Meeting on 22 January 2025 approved the following Rule Changes, arising from the Change to Rule 148 (xii) which will become effective on 8 February 2025:

Index: Fine, failure to maintain accurate records of each Horse in their Care and Control

Definitions: "Restricted Trainer" means a Trainer who shall

(i) only be permitted to have such [text deleted] number of Horses, [text deleted] notified to HRI as being eligible to race at any one time, as may be specified by the Licensing Committee from time to time; and

(ii) not be entitled to be part of a Training Partnership which jointly holds a licence granted by the IHRB to train Horses.

Other NEW Definitions:

"Care and control' refers to the Trainer's obligation to oversee a Horse's management, care, health, and welfare during its active training and racing career, or while the horse is under the Trainer's supervision. This obligation ceases once the horse is no longer under the Trainer's care or management.

Location is any premises, facility, or place where the Horse is kept, including, but not limited to, the Trainer's Training Establishment or other premises, land or buildings, any approved yard(s), or any other site designated by the Trainer for the Horse's management, care, or training.

Calculation of Time. Rule 4

4. When the last day for doing anything under these Rules falls on a Saturday, Sunday, or Public Holiday, it may be done on the first day thereafter that the Office of the IHRB or the Registry Office is open for general business, save as otherwise specified in these Rules.

Powers of the Directors of the IHRB

Rule 20 (xvii)

 To make arrangements for any person appointed by them from time to time to enter without notice the Training Establishment of a Trainer or the establishment where a Horse is stabled during the period specified under Rule 147(iii) whilst under the care of an Overseas Trainer for the purposes of:

(a) inspecting facilities and premises and any relevant documentation or records to determine whether the Rules of Racing, I.N.H.S. Rules, Regulations, Instructions and Orders issued under these Rules are being complied with; and/or

(b) inspecting, examining or testing all Horses **[text deleted]** on the Trainer's Training Establishment or otherwise in their Care and <u>Control</u> **[text deleted]** whether or not such Horse has been entered for a Race or has run in a Race, which may include the taking of Samples for subsequent analysis. Such Samples are to be taken in substantial compliance with any regulations published by the IHRB pursuant to Rule 20(v); the current version of the relevant Regulation is Regulation 14 relating to 'The Taking of Samples From Horses'.

(c) This Rule shall apply to the Training Establishment or other premises wheresoever situated where a Horse is stabled which has been entered for a Race in Ireland.

PART VI SPECIAL CONDITIONS APPLICABLE TO HANDICAPS AND CERTAIN OTHER RACES - Handicaps

Rule 66 (i) (c): A Horse which [text deleted] is in the Care and Control of a Trainer in Ireland pursuant to Rule 148 (xii) with a Flat handicap Rating of less than 60 from a Turf Authority, that has gained its Rating by virtue of its performance while trained outside of Ireland and that has never run in Ireland may, at the discretion of the Handicapper, be qualified to run in an Irish Flat Handicap, without running in a Flat Race in Ireland, with a handicap Rating of not less than 60 in the first instance. In the event that the Handicapper does not exercise this discretion in a particular case, the Horse may become eligible to run in handicaps by qualifying for an Irish Handicap Rating in accordance with Rule 67 or where in the opinion of the Handicapper, having run once or twice in Ireland, the Horse merits a Handicap Rating. A Horse trained outside of Ireland, with a Flat Handicap Rating of less than 60 from a Turf Authority, will not be qualified to run in an Irish Flat Handicap.

Rule 67 (i) For Flat Handicaps

(b) In the case of nursery Handicaps only, a Horse must be returned in **[text deleted]** the <u>Care and Control of a licensed Trainer in Ireland,</u> <u>pursuant to Rule 148 (xii)</u> at the time of entry.

In this Rule a "Flat Race" does not include:

- an Irish National Hunt Flat Race
- a National Hunt Flat Race run in Great Britain
- a Flat Race, for Amateur Riders, run under the Rules of a Specified Authority
- a Flat Race confined to AQPS French Bred Horses.

PART VII RACE HORSES. Passports

Rule 85 (viii) The Passport of <u>each</u> Horse **[text deleted]** <u>on the Trainer's Training Establishment</u> <u>or otherwise in their Care and Control</u>, must be returned to the Racing/Stud Book Authority (as appropriate) of the country in which the Horse is currently resident when the Horse is:

(a) [text deleted] is gelded; or

(b) **[text deleted]** its appearance is significantly different to the passport description (e.g. coat colour, white markings etc.); or

- (c) [text deleted] Dies
- (d) [text deleted]

along with notification of the relevant change.

PART VII RACE HORSES. Qualification of Horses

Rule 87(ii) A Horse is not qualified to start for any Race:

- (a) If a vaccine has been administered within the previous seven days. For the avoidance of doubt there must be six clear days between vaccination and Raceday.
- (b) If a tracheostomy procedure has been performed within the previous 7 days. For the avoidance of doubt there must be 6 clear days between the procedure and Raceday.
- (c) If an intra-articular injection of glucocorticoids has been administered within the previous 15 days. For the avoidance of doubt there must be 14 clear days between the injection and Raceday.
- (d) If it has been administered any substance (by injection, orally or any other method) other than normal feed and water offered by mouth from midnight of the day of the Race Meeting unless an IHRB Veterinary Officer grants a special dispensation.
- (e) If it has been the subject of a neurectomy operation.
- (f) If it has been administered any bisphosphonate
 - (i) on the day of the Race or on any of the thirty days before the day of the Race in which the Horse is declared to run.
 - (ii) and/or if it is less than 4 years of age, with age being taken from the 1st January and foaled on or after the 1st January 2020.
- (g) It is trained by an unlicensed person or following the running of a Race is found to have been trained by an unlicensed person when running in such Race.
- (h) If the Rider nominated to ride is not qualified according to the conditions of the Race or following the running of a Race the Horse is found to have been ridden by a person not qualified to ride in such Race.

- (i) Unless it is currently registered with Weatherbys Ireland within the meaning of the 2014 Regulations and in compliance with Rule 88(i) or in the case of any Horse which is trained outside of Ireland registered with the relevant Stud Book Authority.
- (j) [text deleted]

PART VII RACE HORSES. Equine Influenza Vaccinations

Rule 91 (vi) Once <u>a</u> Horse **[text deleted]** <u>is in</u> <u>a Trainer's Care and Control</u>, vaccinations may not be administered nor certified by a Veterinary Surgeon who has an involvement in the Horse as an Owner (including Company Ownership, Racing Syndicate or Racing Club), Trainer or Handler.

PART VII RACE HORSES. Adverse Analytical Findings in Equines

Rule 96 (ii) When a Horse has been examined or tested and Samples taken pursuant to Rule 20(xvii) and such examination or test or an analysis of such Samples shows the presence of any Prohibited Substance, unless the concentration of the Prohibited Substance is below the threshold level for that substance (if any) as set out in the schedule of Prohibited Substances available on the IHRB website, it shall be a breach of these Rules and the Referrals Committee or the Appeals Body as the case may be, may direct that:

- the Horse be restricted from running for such time as it shall determine;
- the Horse be disqualified from the Race(s) in question, the placings amended and the stake forfeited;
- the Trainer of the Horse be fined not less than €1,000; and/or
- the Trainer's licence be withdrawn for such period as it may consider appropriate.

However, in cases where the Prohibited Substance found is:

- not a Prohibited Substance which is prohibited at all times [text deleted] and
- (b) can be traced to the clinical treatment of the Horse with an Authorised Medicine which has been properly recorded in the Medicines Register maintained by the Trainer and verified in writing by the stable's Veterinary Surgeon (if applicable),

no further action shall be taken.

PART XI TRAINERS, STABLE EMPLOYEES AND APPRENTICES

General Rules for Trainers under Rules of Racing and I.N.H.S. Rules

Rule 145 (iii) A Restricted Trainer [text deleted]

(a) <u>shall only be permitted</u> to have such [text deleted] number of Horses, [text deleted] <u>notified to HRI as being</u> <u>eligible to race</u> at any one time, as may be specified by the Licensing Committee from time to time; and

(b) <u>shall not be entitled</u> to be part of a training partnership which jointly holds a licence granted by the IHRB to train Horses.

PART XI TRAINERS, STABLE EMPLOYEES AND APPRENTICES

General Rules for Trainers under Rules of Racing and I.N.H.S. Rules

Rule 147 (iii) Any Horse which runs in a Race whilst under the care of an Overseas Trainer (excluding one licensed in Great Britain) which remains in Ireland may continue to run in Races in Ireland for the duration of the period specified on the Racing Clearance Notification. In the case of a Horse which runs in a Race whilst under the care of an Overseas Trainer licensed in Great Britain when no Racing Clearance Notification is required, that Horse may continue to run for a period of twenty-eight (28) days from the date of its first run. Such Horse shall remain the responsibility of and in the care and control of, the Overseas Trainer during this time. In such instances it shall be the responsibility of the Overseas Trainer to inform the IHRB of the premises where the Horse is stabled during the period it remains in Ireland and to make arrangements with the proprietor of the premises to facilitate any inspection that may be made in accordance with Rule 20(xvii). It shall be a breach of these Rules for the Overseas Trainer not to do so and render them liable to sanction If at the end of the relevant period specified above, the Horse remains in Ireland it must not run in any Race while under the care of the Overseas Trainer but must be [text deleted] notified to HRI as being in the Care and Control of a Trainer in Ireland pursuant to Rule 148(xii). Any Horse which runs in violation of this Rule shall, on objection under Rule 262, be liable to disqualification and from such disqualification the placings in the Race shall be amended and the stake forfeited.

PART XXI PRESERVING THE GOOD REPUTATION OF HORSERACING

Rule 273 (vii) It shall be a breach of these Rules for any person to fraudulently obtain information respecting a Trial from any person or persons engaged in it or in the service of the Owner or Trainer of the Horses tried or respecting any Horse **[text deleted]** notified to HRI pursuant to Rule 148 (xii) from any person in such service

(xi) It shall be a breach of these Rules for any person being, or having been, in the service of an Owner or <u>Trainer of a Horse</u> **[text deleted]**, which has been notified to HRI pursuant to Rule <u>148 (xii)</u> or being or having been, engaged in or in connection with the Trial of a Horse to convey or give any information respecting the said Horse or the said Trial to any person without the permission of the Owner of the said Horse.

PART XXI PRESERVING THE GOOD REPUTATION OF HORSERACING

Rule 274 (ii) When the IHRB receives notification from a foreign Turf Authority of a sanction (other than a sanction declaring a person a Disqualified Person) imposed by that

Turf Authority for a breach of the Rules of Racing in the jurisdiction of that Turf Authority on:

(a) a person holding a licence/permit from the IHRB, or

(b) an Owner registered in Ireland, or

(c) a Horse in **[text deleted]** a <u>Trainer's Care and</u> <u>Control</u> in Ireland

such sanction shall have effect under these Rules unless it is established to the satisfaction of the Referrals Committee on application under the provisions of Regulation 18 relating to 'Sanctions imposed by a Foreign Turf Authority' that the sanction should not have effect under these Rules.

Regulation 1, LICENSING PROCEDURES FOR TRAINERS' LICENCES. 1.

1.4 They have or will have such minimum number of Horses **[text deleted]** <u>notified to HRI</u> as being eligible to race pursuant to Rule 148 (xii) and such minimum number of runners each year as may be specified by the Licensing Committee as regards each category of Trainer.

Regulation 1, LICENSING PROCEDURES FOR TRAINERS' LICENCES. 7.

Number of Runners and Horses in Training

7.1 All Trainers other than Restricted Trainers must have a minimum of five (5) Horses **[text deleted]** notified to HRI as being eligible to race pursuant to Rule 148 (xii) and a minimum of twelve (12) runners per year (prorated dependent on when their licence is granted). These numbers may be reviewed annually prior to the renewal of a licence.

7.2 In the case of first-time applicants, the applicant should provide a list of the Horses that are likely to be assembled in the event of the application being successful.

Regulation 1, LICENSING PROCEDURES FOR TRAINERS' LICENCES

Section 11. Fit and Proper Person

11.4.6 Whether there are any other issues which are likely either to: significantly impair the ability of the applicant(s) to safeguard the welfare of the Horses **[text deleted]** in <u>the Trainer's Care and Control or to</u> meet the regulatory requirements of the IHRB, or render the applicant (or either applicant in the case of a Training Partnership) a threat to the health, welfare or safety of others involved in horseracing, or to the integrity of the sport.

Regulation 6. Successful Claimants:

2. In the event of a claimed Horse holding any subsequent entries <u>or declarations</u> at the time of the claim such engagements shall pass to <u>the successful claimant</u>. However, if the Horse is ineligible for these engagement(s) pursuant to Rule 148(xii)(d), the successful claimant shall not take up these engagement(s) and shall not be liable for any associated fees. **[text deleted]**

Regulation 6. Successful Claimants

3. [text deleted] The Trainer of a Horse which has been successfully claimed will not be eligible

to run that Horse for a period of three (3) months following the day of the Claiming Race in guestion unless;

(a) they are the successful claimant; or

(b) they are the Trainer pre-designated by the successful claimant when making the claim; or

(c) since that day the Horse was claimed from another Claiming Race or; was sold at public auction; or

(d) the designated Trainer no longer holds a <u>valid</u> licence.

Regulation 18. SANCTIONS IMPOSED BY A FOREIGN TURF AUTHORITY

(a)

When the IHRB receives notification from a Foreign Turf Authority of a sanction imposed for a breach of the Rules of Racing in the jurisdiction of the Foreign Turf Authority on a person holding a licence from the IHRB or a sanction on an Owner registered in Ireland, or on a Horse in [text deleted] a Trainer's Care and Control in Ireland, the person or the Owner of the Horse against whom the sanction was imposed shall be entitled to apply to the Referrals Committee to declare that the sanction shall not have effect under these Rules, but only if the person can satisfy the Referrals Committee that they have exhausted all avenues of appeal in the jurisdiction of the Foreign Turf Authority. Where the Referrals Committee is satisfied that the appellant has exhausted all such avenues of appeal, the only ground which the appellant may rely on is that the principles of natural justice were not complied with by the Foreign Turf Authority in the procedure leading to the sanction.

Appeals & Referrals

Appeals

The Appeals Body, Mr Laurence McFerran (Chairman), Mr Raymond J. McSharry and Mr Noel McCaffrey convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 28 January to consider the appeal of Danny Gilligan (Rider) against the decision of the Raceday Stewards at Fairyhouse on 16 January 2025.

On the day, following the running of the Easter Festival Rated Novice Hurdle, the Raceday Stewards found Mr Gilligan, rider of Find A Fortune, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (first offence), the Raceday Stewards suspended him for two racedays.

The grounds of appeal lodged by Mr Gilligan were that the Raceday Stewards on the day erred in their decision and failed to take all factors into consideration.

At the appeal hearing, evidence was heard from Mr Gilligan. The Appeals Body also watched a recording of the race.

In his evidence, Mr Gilligan stated that he maintained his racing line at all times as the horses were rounding the bend. Mr Gilligan accepted that interference had occurred but, in his opinion, felt that the interference was caused by a horse on his inside,

Having considered the evidence, the Appeals Body dismissed the appeal, upholding the decision of the Raceday Stewards.

The appeal was presented by Mr Kevin Power, Maurice Power Solicitors, Kilmallock, Co Limerick, on behalf of Mr Gilligan. The IHRB was represented by Ms Christine Traynor, IHRB Head of Racing Regulation and Integrity.

Appeals

The Appeals Body, Mr Laurence McFerran (Chairman), Mr Raymond J. McSharry and Mr Noel McCaffrey convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 28January to consider the appeal of Hugh Horgan (Rider) against the decision of the Raceday Stewards at Dundalk on 14 January 2025.

On the day, following the running of the Friday Night Lights Return Dundalk Handicap, the Raceday Stewards found Mr Horgan, rider of Reclaim (GB), in breach of Regulation 10.3(i) in that he failed to give his mount time to respond and having considered him in this regard (fifth offence) they suspended him for 20 racedays.

The grounds of appeal lodged by Mr Horgan were that the Raceday Stewards on the day erred in their decision.

At the appeal hearing, evidence was heard from Mr Horgan and Niall McCullagh, Jockey Coach. The Appeals Body also watched a recording of the race.

In his evidence, Mr Horgan accepted that he was in breach of Regulation 10.3(i), however stated that he felt that he needed to use his whip for corrective purposes as his mount was hanging badly to the right. Mr Horgan explained that he heard a shout as his mount drifted to his right and therefore, he had used his whip twice in quick succession for the safety of those around him. Mr Horgan added that his mount responded and ran straight to the line thereafter.

In his evidence, Mr McCullagh stated that, in his opinion, Mr Horgan had done everything in his power to straighten his mount but initially the horse did not react. Mr McCullagh outlined the measures that Mr Horgan has taken with him as a Jockey Coach.

Having considered the evidence, the Appeals Body dismissed the appeal, holding that the Raceday Stewards had not erred in their decision and that time was not allowed to respond as required by the Rule.

The appeal was presented by Mr Kevin Power, Maurice Power Solicitors, Kilmallock, Co Limerick, on behalf of Mr Horgan. The IHRB was represented by Ms Christine Traynor, IHRB Head of Racing Regulation and Integrity.

Referrals

The Referrals Committee, Mr Martin P. O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 22 January to consider the referral of Mr Rob James (Rider) following the Book Your Easter Early Bird Handicap Chase at Fairyhouse on 22 January 2025.

On the day, the Raceday Stewards wished to interview Mr James concerning his use of the whip in the closing stages of the Book Your Easter Early Bird Handicap Chase. However, as Mr James was unable to attend the enquiry the Raceday Stewards referred the matter to the Referrals Committee to consider if there was a possible breach of Regulation 10.3(g), in that he had used his whip with excessive frequency and Regulation 10.3(f), in that he had used his whip with excessive force.

At the Referrals Committee hearing, evidence was heard from Mr James. The Referrals Committee also watched a recording of the race.

In his evidence, Mr James accepted that he was in breach of Regulation 10.3(g) and apologised for the misjudgement. Mr James stated that his mount was idle in running and that he had miscounted. In relation to a potential breach of Regulation 10.3(f), Mr James explained that he had never been found in breach of this Regulation in his entire career and could only put it down to the fact that it was his first day using a new whip.

Having considered the evidence, the Referrals Committee found Mr James in breach of Regulation 10.3(g) and Regulation 10.3(f). Having considered Mr James's record in each regard, the Referrals Committee suspended Mr James for four racedays in relation to Regulation 10.3(g) and for two racedays in relation Regulation 10.3(f).

The referral was presented by Mr Liam Walsh, IHRB Senior Stipendiary Steward.

Referrals

The Referrals Committee, Mr Laurence McFerran (Chairman), Mr Raymond J. McSharry and Mr Noel McCaffrey convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 28 January to consider the referral of Thomas Gibney (Trainer) following the Albert Bartlett Qualifier Handicap Hurdle at Punchestown on 12 January 2025.

On the day, following the running of the Albert Bartlett Qualifier Handicap Hurdle, the Raceday Stewards wished to interview Mr Gibney, trainer of Sammy Smart, regarding the late arrival of the horse into the parade ring and the late arrival of the horse at the start which contributed to a delay to the off time. As Mr Gibney failed to present himself for interview within 45 minutes of the last race, the Raceday Stewards referred the matter to the Referrals Committee for consideration.

At the referral hearing, evidence was heard from Mr Gibney. The Referrals Committee also heard a recording of the public address announcement requesting Mr Gibney to attend the Stewards' Room.

In his evidence, Mr Gibney accepted that the announcement was made requesting him to the Stewards Room but that he had not heard it as he was still talking to the connections of the horse in the parade ring at the time. Mr Gibney stated that he had then left the parade ring to go to the Owners & Trainers restaurant for something to eat and first became aware that he was wanted by the Raceday Stewards when he received a telephone call from his wife who informed him that the Raceday Stewards wanted to speak to him. Mr Gibney confirmed that his horse had been late into the parade ring but wasn't aware he was wanted by the Raceday Stewards and by the time he got the Stewards' Room all officials had departed.

Having considered the evidence, the Referrals Committee found Mr Gibney in breach of Rule 32(ii), in that his horse was late into the parade ring and Rule 205(i), in that his horse wasn't at the post ready to start at the appointed time. Having considered Mr Gibney's record in relation to both breaches, the Referrals Committee fined Mr Gibney €500 (third offence) for a breach of Rule 32(ii) and €200 (second offence) in relation to the breach of Rule 205(i).

The case was presented by Ms Christine Traynor, IHRB Head of Racing Regulation and Integrity.

Point to Point Stewards Enquiry

Lismore (H) Dungarvan Point to Point Meeting Saturday 1st February 2025

5yo Geldings Maiden

The Acting Stewards interviewed Ms E.P. O'Brien, rider of Boise Idaho, placed second, concerning his use of the whip in the latter stages of this race.
