Irish Horseracing Regulatory Board Notice

Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications of a non-runner or declaration of a reserve **can now be done via RAS** or on the dedicated telephone line (045-445645) at the Office of the I.H.R.B. up to 90 minutes before the time of the first race.

If using the Non-Runner/Reserve Telephone Line, the caller will be asked to provide the Trainer's Horse Racing Ireland account number and Trainer's date of birth. All calls are recorded for verification and security purposes. Veterinary certificates, where required, must be sent as usual to the Office of the IHRB within 72 hours. A Trainer failing to lodge a certificate within the time period shall be liable to a fine in accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner or a non-runner must also do so **via RAS** or on the same dedicated telephone line number by **10am for meetings, (other than floodlit meetings) during the months of November, December and January** and by 11am for all other meetings including floodlit meetings otherwise the reserve will automatically be withdrawn.

If a rider has not been nominated for a declared reserve the Trainer must do so by the time fixed for declaration of a reserve listed within the paragraph above otherwise the declared reserve will automatically be withdrawn.

Declaration of reserves or of non-runners are no longer accepted at a race meeting.

Updates can be made **via RAS** anytime after the publication of Rider Nominations for the meeting up to the specified deadlines.

The dedicated line number (045 - 445645) is in operation from 9am on weekdays when there is a Race Meeting **and from 8.30am on weekends and Bank Holidays in November, December and January.**

IRISH HORSERACING REGULATORY BOARD

The Directors of the IHRB, at their Board Meeting on 5 March 2025 approved the following changes to Rule 20 (xxiii) which will become effective on 6 March 2025:

PROPOSED RULE ON MEDIA: RULE 20 (xxiii)

[Insert within Powers of Directors]

- (a) The Directors of the IHRB shall have the authority to regulate and oversee media attendance at hearings. They may establish rules governing media access, conduct, and reporting to ensure compliance with IHRB Standards, Protocols, and Guidelines. The Directors also have the power to restrict or prohibit media attendance if deemed necessary in the interest of fairness, confidentiality, or the integrity of proceedings.
- (b) Representatives of the media attending hearings must comply with the Guidelines and any instructions issued by the IHRB, the Chairperson, or Directors.
- (c) Hearings of the Referrals Committee or Appeals Body shall be open to media representatives unless the Chairperson directs otherwise. When attending a hearing, the media must respect all instructions and notices as issued by the IHRB, the Chairperson or Directors. The Chairperson may also impose restrictions on the publication of certain matters arising during the hearing.
- (d) The deliberations of Disciplinary Panels shall be conducted in private.
- (e) All hearings shall be recorded by the IHRB, and such recordings shall remain confidential and be the sole property of the IHRB.
- (f) Transcripts of these recordings shall not be made public. No person shall have the right to access or compel the production of a recording, copy, or transcript except where required by law, if they are an interested party, and upon payment of the relevant administrative fee.

IRISH HORSERACING REGULATORY BOARD

The Directors of the IHRB, at their Board Meeting on 5 March 2025 approved the following changes to Rule 298 which will become effective on 6 March 2025:

Part XXIX

STABLE EMPLOYEES BONUS SCHEME

298 (i) – (xi) [TEXT DELETED]

1. Trainers shall make an agreement with registered stable staff on an annual basis in compliance with the HRI Stable Employee Bonus Scheme (SEBS) Guidelines (the "Agreement"). This Agreement must include the date of the meeting, how the monies provided under the SEBS are to be distributed including any individuals or categories of staff who are to be omitted from distribution and be signed in accordance with the SEBS Guidance.
2. A copy of the signed Agreement must be lodged with the Office of the IHRB within seven days of signing or when requested by IHRB.
3. A completed copy of the Agreement must be permanently displayed in a communal area where all staff working at the Trainer's premises can view the agreement.
4. Monies must be distributed in accordance with the Stable Employee Bonus Scheme (SEBS) Guidelines and with the Agreement.
5. Trainers shall make a written declaration that payment has been made in accordance with the Agreement within fourteen days of a request from the IHRB. The declaration must include details of any deviation from or alternation of the terms of the Agreement.
6. Submission of false, inaccurate, or misleading information, or failure to comply with any obligation under this Rule, shall constitute a breach and may be subject to disciplinary action under the Rules.

The Racing Calendar Office of Weatherbys Thoroughbred Ltd. receives entries submitted for acceptance as agents for the Racecourse Authority and only upon the terms of the Standard Conditions. Acceptance of entries is subject to the power to refuse to allow entries to be accepted conferred by the Orders and Rules of Racing on the British Horseracing Authority Ltd. Entries are accepted by the Racing Calendar Office, acting as aforesaid, causing the name of the horse in question to be published as being entered for the race in question either in The Racing Calendar, when the race closes more than six days before running, or, for other races, on the British Horseracing Authority Racing Administration Internet site (www.racingadmin.co.uk) and ordinarily in the Sporting Press.

The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.

IRISH RACE PROGRAMME - STANDARD CONDITIONS

Horses and those in charge of them are received on the terms that the Executive and the Stewards of the respective Meetings are not to be liable for any damage, loss or injury to such horses or persons while in or about the stabling or on the Course from any cause whatsoever.

Nominations can only be made and accepted on the condition that the nominator subjects himself/herself, in all respects to the Rules & HRI Directives under which each race is run.

Races and divisions are run subject to the provisions of Rule 20.

Handicap races closing under the Irish entry system will be calculated at the time of closing. The rating qualification will take into account all performances up to and including the **Sunday** previous to the rating qualification date.

In accordance with Rule 101 (iv), the Qualifying Ratings shall be calculated on each Monday at 12 noon. The Qualifying Rating for each horse shall be equivalent to the horse's current Rating at that time.

Qualifying Ratings For Flat Races

For the purposes of qualification for flat handicaps, in the event of a horse being assigned a separate handicap mark for "all weather" handicaps, the "all weather" qualification rating will be the horse's qualifying rating for "all weather" racing. In the event of a horse being assigned only one handicap rating, the same qualifying rating shall apply for qualification purposes to handicaps run on both turf and "all weather" surfaces.

Entries & Declarations

Entries for horses trained outside of Ireland must be made through the relevant Turf Authority and close by 11am on the same day they close with Horse Racing Ireland. Entries for early closing races are accepted through the relevant Turf Authorities on the same day they close with Horse Racing Ireland at 12 noon.

The Raceday Stewards enquired into an incident in the closing stages of this race involving Raadobarg, ridden by D. Egan, unplaced, and Fratas, ridden by W. Joyce, unplaced, where it appeared Fratas had to check. Evidence was heard from the riders concerned. D. Egan stated that his mount shifted sharply to his left and he corrected him immediately as he was aware of the horse on his outside. W. Joyce stated that his race was run and his mount was retreating when he took a precautionary check. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that no further action was warranted.

The Raceday Stewards interviewed A.J. Slattery, rider of Smooth Tom, concerning his use of the whip in the closing stages of this race. Evidence was heard from the rider concerned who accepted that he was in breach of the Regulation and apologised for his actions.
