Irish Horseracing Regulatory Board Notice

Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications of a non-runner or declaration of a reserve **can now be done via RAS** or on the dedicated telephone line (045-445645) at the Office of the I.H.R.B. up to 90 minutes before the time of the first race.

If using the Non-Runner/Reserve Telephone Line, the caller will be asked to provide the Trainer's Horse Racing Ireland account number and Trainer's date of birth. All calls are recorded for verification and security purposes. Veterinary certificates, where required, must be sent as usual to the Office of the IHRB within 72 hours. A Trainer failing to lodge a certificate within the time period shall be liable to a fine in accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner or a non-runner must also do so **via RAS** or on the same dedicated telephone line number by **10am for meetings, (other than floodlit meetings) during the months of November, December and January** and by 11am for all other meetings including floodlit meetings otherwise the reserve will automatically be withdrawn.

If a rider has not been nominated for a declared reserve the Trainer must do so by the time fixed for declaration of a reserve listed within the paragraph above otherwise the declared reserve will automatically be withdrawn.

Declaration of reserves or of non-runners are no longer accepted at a race meeting.

Updates can be made **via RAS anytime after the publication of Rider Nominations for the meeting up to the specified deadlines.**

The dedicated line number (045 - 445645) is in operation from 9am on weekdays when there is a Race Meeting **and from 8.30am on weekends and Bank Holidays in November, December and January.**

Appeals & Referrals

Referral

The Referrals Committee, Mr Laurence McFerran (Chairman) Mr Noel McCaffrey and Mr Raymond J McSharry convened in the Offices of the Irish Horseracing Regulatory Board on Tuesday, 28 January 2025 to consider whether Brian Duffy (Trainer) was in breach of any rules of racing following a report from the IHRB Licensing Department.

The Referrals Committee were asked to consider a report from the IHRB Licensing Department and heard evidence from Mr Brian Duffy, Trainer, Mr Frank Duffy and Mr Mark Flanagan.

The IHRB submission outlined that in June 2023, the IHRB Licensing Department granted Mr Duffy's request to continue as a licensed trainer while he pursued a job opportunity in France for a temporary period of eight weeks. However, it was noted that from that point onward, the Licensing Department received no further correspondence from Mr Duffy regarding his residency status until September 2024, when he contacted the Licensing Department to raise concerns about holding an Irish trainer's licence while living in France. During this call, he acknowledged that he had runners from his yard in Meath and expressed uncertainty about whether this was compliant with licensing regulations. In the intervening period, Mr Duffy renewed his trainer's licence in January 2024, listing his Trim, Ireland address, despite continuing to reside in France. During this time, he had one horse in training in Ireland, who had raced during this period.

In his evidence at the referral hearing, Brian Duffy stated that he moved to France to pursue a job opportunity but was uncertain about the duration of his stay, as he had not yet secured a fulltime contract. He acknowledged that he initially intended to stay only a short time and had departed with his family remaining in Ireland. During that period, he remained in daily contact with his father, who was overseeing the training and welfare of the horse stabled at his Trim facility. Mr Duffy emphasised that all decisions regarding the horse's care, training, and management were made by him directly, with him maintaining daily contact with his training establishment. Mr Duffy admitted that it was wrong to list his Trim address on his 2024 licence renewal form, and he accepted that he had made a declaration that was wrong, but he explained that at the time his family had moved to France but he believed he would be returning to Ireland at the end of the school term. Mr Duffy accepted he was in breach of Rule 145(i)

for failing to provide accurate information on his licence renewal application.

In his evidence, Frank Duffy, explained he was an Authorised Representative for the stable and had extensive experience in the racing industry. Mr Duffy stated that he was in daily contact with his son discussing every aspect of the horses care, including feed rations, training schedule, and medical updates. He emphasised that while he oversaw the horse's daily welfare, all decisions were made solely by Brian Duffy.

In his evidence, Mark Flanagan stated that he rode the horse on a daily basis and he got instructions from Brian Duffy on the exercise regime of the horse. He confirmed that Mr Duffy remained actively involved in all decision-making regarding the horse management and training.

Having heard the evidence, the Referrals Committee reserved their decision.

Having considered the evidence, the Referrals Committee issued the following decision:

"The committee found that having considered aggravating and mitigating factors, that Mr Duffy is in breach of Rule 145(i), which is a very serious matter. The accuracy of personal information given by a Licensee to a Regulator, in this case the IHRB, is fundamental to protecting the integrity of the entire system and in acknowledging the acceptance of this breach by Mr Duffy and taking into account all mitigation, he was fined €5,000. The fine to be paid before close of business on Wednesday 5 March 2025."

Mr Brian Duffy will be required to revert to the Referrals Committee seeking approval to re-apply for a trainers licence in Ireland. Until such approval is forthcoming and a trainers licence, either Restricted or Full, has been granted by the Licensing Committee, Mr Brian Duffy has given an undertaking not to engage in any training activities or any aspect of training racehorses in this jurisdiction.

The case was presented by Christine Traynor BL, IHRB Head of Racing Regulation and Integrity and Mr Duffy was represented by Mr David Geoghegan instructed by Kevin Power Solicitor.

Appeal

The Appeals Body, Mr Laurence McFerran (Chairman), Mr Robert Dore and Dr Paddy Molony convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 26 February 2025 to consider the appeal of Eric McNamara (Trainer) and Conor McNamara (Rider) against the decision of the Stewards at Clonmel on 13 February 2025 following the SIS Supporting Irish Racing Novice Handicap Chase.

On the day, the Stewards found both Eric McNamara and Conor McNamara in breach of Rule 212A(i), in that they deliberately or recklessly caused or permitted a horse to run other than on its merits. Having considered their records in this regard, the Raceday Stewards fined Eric McNamara €6,000, suspended Conor McNamara for 40 days and suspended Mount

Ferns from running for 90 days under the provisions of Rule 212C(D).

The grounds of appeal lodged by Eric McNamara and Conor McNamara were that the Raceday Stewards erred in their decision on the day.

At the Appeal Hearing, evidence was heard from Eric McNamara and Conor McNamara. The panel also viewed a recording of the race and considered a submission from Emmet McNamara which included video evidence of Mount Ferns running in races prior to Clonmel.

In his evidence, Eric McNamara stated that he accepted the findings of the IHRB Veterinary Officer on the day which was that Mount Ferns was post-race normal. However, Mr McNamara explained that when Mount Ferns returned home he noticed that the horse was lame as he was unloaded from the lorry. Mr McNamara suggested that possibly Mount Ferns appeared postrace normal at the time due to adrenaline. Mr McNamara confirmed that he got his own veterinary surgeon to examine Mount Ferns the following day and submitted videos and written documentation to confirm that the horse was lame on three legs when examined. Mr McNamara admitted that he feared Clonmel might not be a track that would suit his horse but explained that he ran him as there was no suitable race with similar conditions again until late March. Mr McNamara confirmed he was satisfied with the ride and felt that the rider did everything in his power given how badly the horse was hanging.

In his evidence, Conor McNamara confirmed his instructions were to jump off mid-division and to try and deliver a late challenge. Mr McNamara said that Mount Ferns was a difficult ride and has previously had issues with hanging to the right in previous runs. Mr McNamara further added that this tendency to hang was once again evident in the race in question and the horse became almost uncontrollable as they were coming down the hill the final time. Mr McNamara stated that he felt he did everything in his power to keep the horse straight by adjusting his body weight to the left and tightly grabbing his left rein. Mr McNamara reiterated that he prioritised safely finishing the race and believed he did so to the best of his ability. Mr McNamara accepted he had failed to report his mount hanging to the right to the Clerk of the Scales after the race.

Having considered the evidence and the additional submissions made by the appellants, the Appeals Body allowed both appeals.

The Acting Stewards interviewed Mr E.P. O'Brien, rider of Ballingurteen, placed second, concerning his use of the whip in the latter stages of this race. Evidence was heard from the rider concerned.

Having viewed a recording of the race and considered the evidence, the Acting Stewards were of the opinion that the rider was in breach

of Regulation 58. 3.(h) in that he had used the whip with his arm being or appearing to be above shoulder height. Having taken his previous record into consideration, the Acting Stewards suspended Mr E.P. O'Brien for two Point to Point racedays.

5yo & Upwards Adjacent Maiden

The Acting Stewards interviewed Mr M.J. Kenneally, rider of Southern Point, placed third, concerning his use of the whip in the latter stages of this race. Evidence was heard from the rider concerned.

Having viewed a recording of the race and considered the evidence, the Acting Stewards were of the opinion that the rider was in breach of Regulation 58. 3.(i) in that he had used the whip without allowing or appearing to allow his mount at least three strides to respond. Having taken his previous record into consideration, the Acting Stewards suspended Mr M.J. Kenneally for three Point to Point racedays.

East Down (F) Point to Point Meeting, Saturday 1 March 2025

Following the running of the first Race and having consulted with the IHRB Medical Officer, the Acting Stewards in accordance with Regulation 22 (x) abandoned the remainder of the meeting due to the unavailability of a registered road ambulance.

Carlow Farmers (F) Point to Point Meeting, Sunday 2 March 2025

5yo & Upwards Adjacent Maiden

The Acting Stewards enquired into the start of this race, as it appeared that Lyreen Og (GB), ridden by Mr J. Costello, placed first, ducked right after the start had been effected and ran outside the chute before rejoining the other runners and continuing to race.

Evidence was heard from the rider concerned who stated that his mount cocked his jaw and ran outside the chute. Having viewed a recording of the start and considered the evidence, the Acting Stewards deemed that a fair start had been effected, and as they could not find any breach of a Point to Point Regulation, they took no further action.

The Racing Calendar Office of Weatherbys Thoroughbred Ltd. receives entries submitted for acceptance as agents for the Racecourse Authority and only upon the terms of the Standard Conditions. Acceptance of entries is subject to the power to refuse to allow entries to be accepted conferred by the Orders and Rules of Racing on the British Horseracing Authority Ltd. Entries are accepted by the Racing Calendar Office, acting as aforesaid, causing the name of the horse in question to be published as being entered for the race in question either in The Racing Calendar, when the race closes more than six days before running, or, for other races, on the British Horseracing Authority Racing Administration Internet site (www.racingadmin.co.uk) and ordinarily in the Sporting Press.

This declaration is not considered as an entry. Trainers are to make their entries and other declarations directly online. They must also supply a complete race record of all the performances of the horse(s) entered on the Internet, by fax (33 1 47 61 93 37) or email (fgperf@france-galop.com). The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.

043B Book Online @ DundalkStadium.com M'dn At the request of the Raceday Stewards, L.F. Roche, rider of Havana Goodtime (GB), trained by Gavin Cromwell, reported to the Stewards' Secretaries that his mount jumped a little awkwardly from the stalls and was outpaced throughout.

043C Dundalk Winter Series Championship H'cap The Raceday Stewards informed Gavin Cromwell, trainer, that Tommy McJohn, would have to be recertified before being declared to run from stalls again.

The Raceday Stewards enquired into possible interference inside the final furlong involving Lyle The Crocodile, ridden by S. Coen, placed first, and Tam Lin, ridden by C.T. Keane, placed third, where it appeared interference may have occurred. Evidence was heard from the riders concerned. In his evidence, C.T. Keane stated that the leader was leaning a little to his left but that the interference was very minimal and did not affect his placing. S. Coen stated that his mount leaned very slightly left close to the line under a left hand drive. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were of the opinion that while Lyle The Crocodile had caused interference to Tam Lin, he did not improve his finishing position as a result of this interference so no alteration was made to the Judge's placings. Furthermore, the Raceday Stewards did not apportion blame to any rider and therefore took no further action.

Egan stated that the runners funnelled from the outside on the approach to the first bend but felt he did his best to avoid contact with the horses on his inner. Having viewed the recording of the race and considered the evidence, the Raceday Stewards did not apportion blame to any rider and took no further action.

N.M. Crosse, rider of Angelo Pio, trained by Joseph Patrick O'Brien, reported to the Clerk of the Scales that he had to check going into the first bend.

045B Adare Manor Opportunity M'dn H'dle The Raceday Stewards enquired into an incident after jumping the first hurdle involving Harbour Highway, ridden by Conor Clarke, placed third, and Solsbury Hill, ridden by C.G. O'Dwyer, placed first, where it appeared Solsbury Hill ran short of room and hit the rails. Evidence was heard from the riders concerned. Conor Clarke stated that his mount jumped right and as he came back to the rails he did not realise the horse on his inner was there and he took his racing line. C.G. O'Dwyer stated that he ran short of room and hit the rail as the field moved across to the rails. Having viewed the recording of the race and considered the evidence, the Raceday Stewards found Conor Clarke was in breach of Rule 214 in that he had ridden carelessly. Having considered his record in this regard (first offence), the Raceday Stewards suspended Conor Clarke for four race days.

The IHRB Veterinary Officer examined Fortune The Brave, trained by John C. McConnell, at the request of the Raceday Stewards and reported the animal to be post-race normal.

J. Coen, rider of Glyde Ranger, trained by T.G. McCourt, reported to the Clerk of the Scales that his mount refused at the first down the back straight.

The Raceday Stewards enquired into the running and riding of Harbour Highway, ridden by Conor Clarke, and trained by Emmet Mullins. Evidence was heard from the rider and trainer concerned. Conor Clarke stated that his instructions were to jump off mid-division and ride his mount to hit the line well. Emmet Mullins confirmed the instructions given and expressed his satisfaction with the ride. He added that he instructed the rider not to use the whip today unless it was the difference between winning and losing, as his charge has been disappointing and he is trying to restore his confidence. Furthermore, he stated that the tongue tie was left off today on the recommendation of the owner's equine physio. The Raceday Stewards also received a report from the IHRB Veterinary Officer who stated that Harbour Highway was post-race normal. Samples were taken for further analysis. Having viewed the recording of the race and considered the evidence, the Raceday Stewards noted the explanations given and took no further action.

T. Power Roche stated that his mount rolled around in the blinkers and over reacted when he corrected him. K.M. Donoghue stated that the gap opened and he was in it when he received contact from his outer. He added that as soon as he shouted, Mr. Power Roche straightened his mount. Having viewed the recording of the race and considered the evidence, the Raceday Stewards did not apportion blame to any rider and took no further action.

The Raceday Stewards enquired into an incident in the closing stages involving Down Around, ridden by T. Power Roche, placed fifth, and Gamigin, ridden by J.S. McGarvey, placed fourth, where it appeared Down Around momentarily ran short of room. Evidence was heard from the riders concerned. T. Power Roche stated that his race was run and he suffered no interference. J.S. McGarvey stated that his mount fell into the rail as he passed the horse on his inner but he was aware he was there and felt he was clear at the time. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that no further action was warranted.

045D(ii) Cancer Fund For Children H'cap H'dle (Division Two) The Raceday Stewards enquired into the apparent improvement in form of Darcy's Friend, trained by Emmet Mullins, placed first, as compared with his recent form. Evidence was heard from the trainer concerned who stated that he has the horse since September and it has always shown ability. He felt it was well ahead of his mark and he fancied it today.
